In the absence of any descendants of Maurice Ravel (1875-1937) or of his brother (and first rights holder) Édouard Ravel (1878-1960), and in default of any research centre dedicated to Ravel, the non-profit association Les Amis de Maurice Ravel has been established (under association loi 1901) with the object of assisting the promotion of the life and work of Maurice Ravel by means of:

- the timely creation of **celebrations of Ravel on his anniversary dates**, and in the first instance on the 75th anniversary of the death of Ravel on Friday 28 December 2012;
- the **development of an international network of admirers of Ravel**, whether they be musicians, musicologists, librarians, collectors, or music-lovers in general; and also including the descendants of the friends, interpreters and correspondents of Maurice Ravel;
- the **documentation of all sources for Ravel** (manuscripts, printed publications, images, recordings, audio-visual materials), in any language, whether by Ravel, addressed to Ravel, or referring to Ravel and his circle ; **acquisitions of Ravel's documents** (autographs, iconography, etc).
